Minutes of the Council Meeting held at the Thorncombe Village Hall on Tuesday 7th July 2015 at 7.30pm

Present: Cllr's R Arnold (Chairman), S Dunford, S Welford, J Higgs, R Peacock, M Stead , D Marsh, J Higgs and C Sowerbutts

In Attendance:-The Clerk (Mr J Vanderwolfe), Cllr Sewell (West Dorset District Council) and five members of the public.

021	Apologies Cllr D Turner (Dorset County Council)
022	Declarations of Interest There were no Declaration of Interest made at this stage of the meeting.
023	Minutes The minutes of the meeting held on the 14 th May 2015 were adopted as a true record; and were signed by the chairman.
024	Matters Arising Lyme Regis Town Council would confirm after their Full Council meeting whether we could loan their Speed Indicator Device (SID). We would have it for an eight week period but would need to purchase a battery. Highways had confirmed that they would not permit mirrors to be placed alongside the highway. Cllr Sewell commented that Broadwindsor had placed a mirror beside the highway and it was agreed that this would be looked into. Cllr S Dunford reported that some more work

	<p>had been undertaken to highways at Goughs Barton. Agreed that Jasmine Hill would be our school representative. Cllr D Marsh reported back to the meeting on parking problems in the village. He had approached Magna who had stated that they would provide additional parking spaces in Gribb View. There were however concerns regarding children playing near the bus shelter. It was hoped that Magna might provide some financial assistance to the playing field which might take the children away from the street. The item was on the agenda for the F&GP meeting.</p>
025	<p>Police Report and Neighbourhood Watch Cllr M Stead reported that new Neighbourhood Watch signs were now on display in the village.</p>
026	<p>Beneath the Vale –Complaint against Upper Marshwood Vale Parish Council (UMVPC) Cllr R Arnold reported that he had received a letter from Cllr M Bowditch, Chairman of UMVPC apologising for the article relating to the Neighbourhood Plan meeting held in Thorncombe in April. Cllr Arnold had replied to Cllr Bowditch and had also seen the retraction article that was to be placed in the next edition of the magazine. Cllr Dunford stated that he was satisfied with the letter, but remained concerned about the correspondence sent to the Thorncombe Village Trust. Resolved that the matter be declared closed and that a copy of the letter to Cllr Arnold be displayed on the notice board.</p>
027	<p>Democratic Period Cllr C Sowebutts, speaking as a parishioner, informed the meeting that Sadborough Estate were looking into the possibility of having a Solar Far. There would be a public consultation, and members of the council would be invited to attend a viewing prior to the public meeting opening. The clerk informed Cllr Sowebutts that as he was involved in the planning process he would have a Disclosable Pecuniary Interest when the Council were presented with the application.</p> <p>A member of the public asked that changes to council meetings be displayed on the notice boards. It was pointed out that the change in meetings had been placed as an article in the magazine, however the comment was duly noted. It was understood that three new telegraph poles had been erected below Gribb View. A parishioner had written to BT why they had been erected and to object.
